How you can leave a legacy

Of course, family and friends will be your priority but after making provision for them, FPH would be delighted if you would consider supporting FPH in your will.

You should contact your solicitor and can either choose to add specific wording to your will, if you have not already made one, or to update your current will using a codicil.

Types of legacy you might want to consider:

Residuary legacy

This is a gift of the remainder of your estate after all other bequests are made and any taxes and other administration expenses are cleared.

Model wording for a residual gift:

I give (%) of the residue of my estate to The Faculty of Public Health of the Royal Colleges of Physicians of the United Kingdom, 4 St Andrews Place, London NW1 4LB (registered charity no 263894) for the general purposes of the charity and the receipt of the proper officer for the time being of the charity shall be sufficient discharge for my Executors.

Pecuniary legacy

This is a gift of a fixed sum of money stated at the time you make the will.

Model wording for a pecuniary gift:

I give the sum of (X) to The Faculty of Public Health of the Royal Colleges of Physicians of the United Kingdom, 4 St Andrews Place, London NW1 4LB (registered charity no 263894) for the general purposes of the charity and the receipt of the proper officer for the time being of the charity shall be sufficient discharge for my Executors.

Specific legacy

This is a gift of a named item such as a painting, building or land.

Contingent legacy

This is a gift which is dependent on a specific event which may, or may not, occur.

Life interest/Reversionary bequest

This is a gift which is the right to enjoy either a property or the proceeds of an investment until either death or the case of some reversionary event.

Gift in remainder

An organisation such as the FPH may benefit from a property once a life tenant has died and the property reverts, for example.

Letting FPH know

If you are thinking of leaving a gift in your will to FPH or if you have already made provision, then thank you very much.

We recognise that this is a very personal gift and promise to put your bequest to good use. It would also help us to know about your gift. This will enable us to plan for the future, enable us to thank you properly and involve you more in the life of your professional organisation.
