## Finance function and preparation of year end accounts

The finance department is staffed by a part-time (Chartered) Accountant and full-time Financial Administrator overseen by the Director of Business Services.

Membership subscriptions and associated income streams are processed through a bespoke CRM system. The accounts package used is Sage 50 (not integrated with CRM) and the payroll is produced in-house.

The organisation is VAT-registered although only a small proportion of outputs are VATable and partial exemption rules apply.

Management accounts comparing actuals with budgets are produced bi-monthly.

Statutory year end accounts are produced by the Accountant using excel from the Sage data along with supporting schedules and reconciliations. The accounts and audit papers for the financial year 2018 will be available from Mid- February and it is envisaged that the audit should be completed by the end of April.
