The National Institute for Health and Care Research (<u>NIHR</u>) is the largest funder of health and care research in the UK.

NIHR activity is managed by the NIHR Coordinating Centre (NIHRCC). NIHRCC is the collective term for the coordination function operating from several sites across the UK. This NATP placement opportunity relates only to the site based at the University of Southampton, referred to as 'NIHRCC (Southampton)'. Within NIHR, this centre is also known as the NIHR Evaluation, Trials and Studies Co-ordinating Centre (<u>NETSCC</u>).

NIHRCC (Southampton) commissions over £250m of healthcare, public health, and social care research per year, managing the identification, prioritisation, funding, delivery, publication, and dissemination of high-quality research. It also leads other NIHR initiatives to meet the needs of the public, patients, NHS, and social care sector. NIHR research programmes co-ordinated by NIHRCC (Southampton) include the:

- Public Health Research (PHR) Programme
- Efficacy and Mechanism Evaluation (EME) Programme
- Health and Social Care Delivery Research (<u>HSDR</u>) Programme
- Health Technology Assessment (<u>HTA</u>) Programme
- Evidence Synthesis (ES) Programme
- Global Health Research (<u>GHR</u>) Programme.

Opportunities on placement include identifying gaps in evidence, honing research questions to articulate the research needed to fill those gaps, and developing research briefs that underlie NIHR 'calls for research' that are advertised nationally. Research briefs are based on reviews of evidence, and their development can involve networking with relevant stakeholders including leaders in the field, local and national government, charities, and other organisations. Briefs are discussed and approved by committees of practitioners and academics, who bring academic rigour and who ensure that planned research is aligned with health, public health, or social care priorities.

A placement at NIHRCC (Southampton) will confer an understanding of the NIHR, how funding decisions are made, and of research methodology. During the placement, Registrars will work as part of a team, and can attend committees such as the PHR Prioritisation Committee and Funding Committee. Other opportunities include joining meetings within the Monitoring function, which provides support to, and keeps track of, research studies to ensure that academic teams holding NIHR contracts deliver to time and target. Additional opportunities based around ad-hoc project work, cross-NIHR initiatives, and leadership and management may be available, and can be tailored, where possible, to the training needs of the Registrar.

A large proportion of work at NIHRCC (Southampton) is now conducted remotely, utilising email and videocalls. As such, it would be possible for a training placement to be conducted entirely remotely, or almost entirely remotely. Where possible, occasional attendance at the University of Southampton site in person, and/or attendance at funding committees in person (typically over 1-2 days in London), would be advantageous.

Registrars on placement typically become involved in identifying gaps in evidence, honing research questions, and developing research briefs, which includes liaising with relevant stakeholders.

In the past Registrars have worked on a wide range of research calls, for example on national tobacco control plans (developed in collaboration with a national charity and academic coalition), asylum seeker and refugee health, urban design, and fracking.

Other opportunities can include joining meetings within the Monitoring function, and becoming involved in ad-hoc project work and cross-NIHR initiatives. Placements can be tailored, where possible, to the training needs of the Registrar.

Specific areas of interest can be considered during placement discussions.

Placements are most suited to Registrars in the latter stages of training who are post-Final Membership Examination (formerly known as post-Part B).

Part-time and split/joint placements are welcomed.
